DECISION OF THE GOVERNOR OF BANTEN NUMBER 561 / Kep.643-Huk / 2016

CONCERNING SECTOR MINIMUM WAGE DETERMINATION FOR TANGERANG CITY AND CILEGON CITY 2017

GOVERNOR OF BANTEN,

Considering: that in order to implement the provisions of Article 89 paragraph 3 of Law No. 13 of 2003, it deemed is necessary to stipulate a Governor Decision on Sector Minimum Wage Determination for Tangerang City and Cilegon City 2017.

DECIDE

to Enact:

- ONE : Determination of sector minimum wages for
Tangerang City and Cilegon City 2017, with
categories and amounts as listed in Appendix I
and Appendix II of this Decision.
- TWO : Said Minimum Wages for Tangerang City
mentioned in the dictum ONE are set out in five
(5) Business Categories while Sector Minimum
Wages for Cilegon City are set out in three (3)
business categories.
- THREE : Said sector minimum wages for Tangerang City
and Cilegon City mentioned in the dictum ONE
apply only to workers with less than 1 (one)
year of service.
- FOUR : Amounts of the wages for workers with more
than 1 (one) year of service is based on a written
agreement between workers and/or trade
union and the employer.
- FOUR : This Governor Decision shall come into force as
from January 1, 2017.
